Your personal data is collected for:

- Correspondence
- Checking against terrorism and embargo lists
- Obtaining creditworthiness information
- Performing contracts
- Inclusion in a database of customers
- Sending Christmas greetings (consent)
- Sending the newsletter (consent)
- Planning, completing and documenting audits
- Documenting compliance with the requirements to accreditation bodies, authorities, standard institutions and customers and to enable verification

Processing on the basis of consent pursuant to Art. 6 para. 1 sentence 1 point a) GDPR

# 7. Rights of the data subject

You have the following rights according to the General Data Protection Regulation:

Where your personal data is processed, you have the right to obtain information from the controller



about the data stored concerning you (Art. 15 GDPR).

Where inaccurate personal data is processed, you have a right to rectification (Art. 16 GDPR).

Where the legal requirements are satisfied, you may obtain erasure or restriction of processing and may object to processing (Art. 17, 18 and 21 GDPR).

Where you have consented to data processing or a data processing agreement exists and the data processing is carried out with the help of automated procedures, you may have a right to data portability (Art. 20 GDPR).

You also have the right to lodge a complain with a supervisory authority (Art. 77 GDPR).

# 8. Right to withdraw consent

Where you have consented to processing by the controller by means of a suitable declaration, you may withdraw your consent at any time with effect for the future by sending an email to vertrieb@sfbgroup.com. Withdrawal of consent does not affect the lawfulness of processing carried out on the basis of consent until such time as it is withdrawn.
